"It is truly said (good reader) that Error (Ignorance being her inseparable twin) doth in her proceeding so infinitely multiply herself, produceth such monstrous and strange chimaeras, floateth in such and so many uncertainties, and sucketh down the poison from the contagious breath of ignorance, as all such into whom she infuseth any of her poisoned breath, she dangerously infects or intoxicates; and that which is wonderful, before she can come to any end, she brings all things (if she be not prevented) by confusion to a miserable and untimely end: *naturalia & vera artificialia sunt finita, nullus terminus falso, error immensus*. On the other side, truth cannot be supported or defended by anything but by truth herself, and is of that constitution and constancy, as she cannot at any time, or any part or point be disagreeable to herself; she hateth all bombasting and sophistication, and bringeth with her certainty, unity, simplicity, and piece at last: *putida salsamenta amant organum, veritas per se placet, honesta per se decent, falsa fucis, turpia, phaleris Indigent*. Ignorance is so far from excusing or extenuating the error of him that had power to find out the truth (which necessarily he ought to know) and want only will to seek it, as she will be a just cause of his great punishment: *quod scire debes & non vis, non pro ignorantia sed pro contemptu naberi debet*. Error and falsehood are that condition, as with any resistance they will in time of themselves fade and fall away: but such is the state of truth, that though many do impugn her yet will she of herself ever prevail in the end, and flourish like the palm-tree; she may peradventure by force for a time be trodden down, but never by any means whatsoever can she be trodden out. There is no subject of the realm, but being truly instructed by good and plain evidence of his ancient and undoubted patrimony and birth-right, (though he hath for some time by ignorance, false persuasion or vain fear, been deceived or dispossessed,) but will consult with learned and faithful counsellors for the recovery of the same: the ancient and Excellent laws of England are the birthright, and the most ancient and best inheritance that the subject of the realm have; for by them he enjoyth not only his inheritance and goods in piece and quietness, but for his Life and his most dear country in safety. And for that I fear that many of my dear countrymen, (and most of them of great capacity, and excellent parts,) for want of understanding of their own evidence, do want the true knowledge of their ancient birth-right in some points of greatest importance; I have in the beginning of this my fifth work, directed them to those that will not only faithfully counsel, and fully resolve therein, (such as cannot be daunted with any fear, moved by any affection, nor corrupted with any reward,) but also establish and settle them in quit and lawful possession. Upon just grounds to rectify an error in a man's own mind is work of a clear understanding, and of a reformed will, and frequent with such as be good men, and have sober and settled wits."

THE FIFTH PART OF THE REPORTS of SIR EDWARD COKE, KNT.

"Nota, the original writs are (as it were) the foundations and grounds of the law, and, as it appears here by *Littleton*, are of great authority for the proove of the law in particular cases. Section 93b.

"*Writ of right* (briefe de droit)," *breve de recto*. Writs of right be of two natures: 1. A writ of right, whereof *Littleton* here speaketh, which is the highest writ of all other reall writs whatsoever, and hath the greatest respect, &c. and the most assured and finall judgement; and therefore this writ is called a writ of right; and this in old books is called *dreit dreit*; and this writ *est darrein remedie de tous recoveries enter tous ordres des pleas*; and the jury in this writ is called *magna assisa*, or *magna jurata*, as *Littleton* here saith. 2. Writs of right in their nature, as the *rationabili parte*, and *ne injuste vexes*. Section 158b.

"*A right cannot die.*" *Dormit aliquando jus, moritur nunquam*. For of such an high estimation is right in the eye of the law, as the law preserveth it from death and destruction: trodden downe it may bee, but never trodden out. Section 279b.

"*It is a principle in law, &c.*" *Principium, quod est quasi primum caput*, from which many cases have their originall or beginning, which is so strong, as it suffereth no contradiction; and therefore it is said in our books, that ancient principles of the law ought not to be disputed, *Contra negantem principia non est disputandum*. Section 343a.

And hereby it may appeare, that it is not safe for any man (be he never so learned) to be of counsell with himselfe in his owne case, but to take advice of other great and learned men. Section 377b.

"I will not presume &c." Here observe the great modesty and mildness of our author, which is worthy of imitation; for *Nulla virtus, nulla scientia locum summet dignitatem conservare potest sine modestie*. And herin our author followed the example of Mosses, who was a judge, and the first writer of the Law; for he was *mitissimus omnium hominum qui fuit in terris*, as the holy history testifieth of him.

"The arguments and reason in the law &c." *Ratio est anima legis*; for then are we said to know the law, when we apprehend the reason of the law; that is, when we bring the reason of the law so to our owne reason, that wee perfectly understand it as our owne; and then, and never before, we have such an excellent and inseparable propertie and ownership therein, as wee can neither lose it, nor any man take it from us, and will direct us (the learning of the law is so chained together) in many other cases. But if by your studie and industrie you make not the reason of the law your owne, it is not possible for you long to retaine it in youre memorie. Section 395a.
